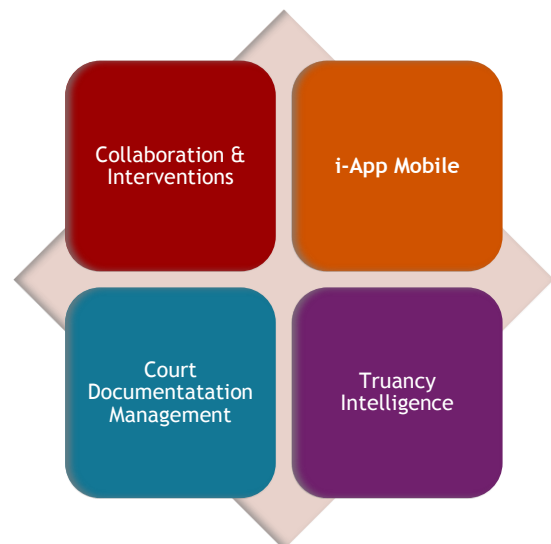

### Collaboration & Interventions (C&I)

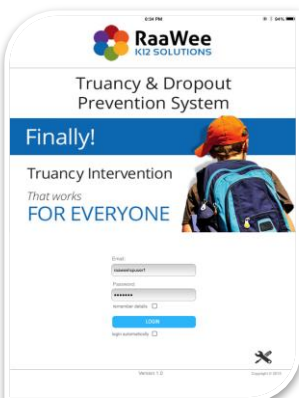

## Court Documentation Management (CDM)

TDPS creates optimal paperwork efficiencies for Student Support and Attendance personnel, so that they spend their valuable time on outreach and counseling for students and families with attendance challenges.

Truancy Court Adjudications are minimized due to tightly coordinated efforts in C&I and TI modules. Court-related Affidavits and forms customized to the local Juvenile court requirements are created by one click and are hosted at a centralized location. ## Interventions App (i-App)

Many interventions are executed by Attendance Personnel out in the field. In order to best assist students and their guardians, they need on-the-go access to current information. i-App is our TDPS iPad application designed to aid them in the field. Be it a Home visit, Address verification, Attendance Board/Review Team meetings, or representing School District at the Juvenile Court, i-App is their companion toolkit for documentation and instant information access. It allows documenting incidences as they occur, thereby improving accuracy and timeliness. i-App also provides practical mapping, route generation and mileage tools that makes field time & vehicle usage more efficient and cost-effective.

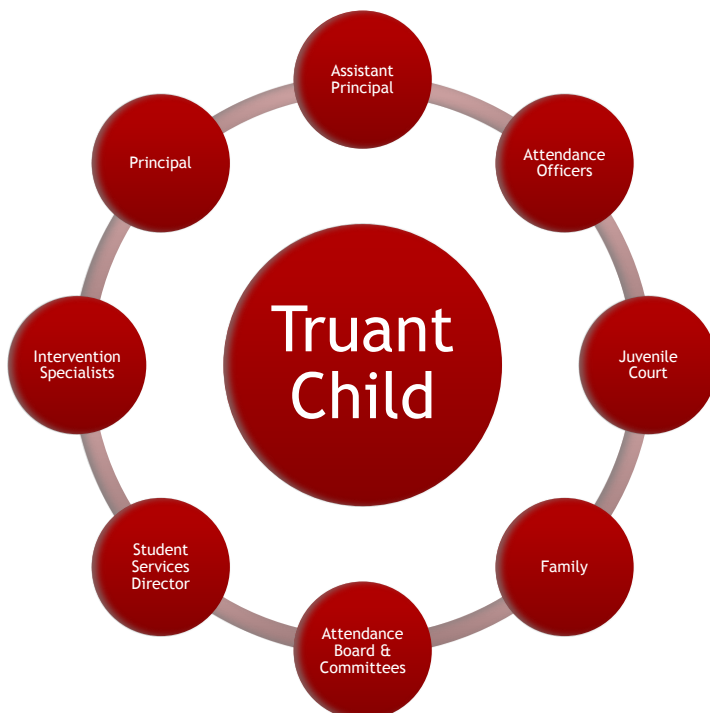
